## What data do we collect?

ADEIMF and Confnow! collect the following data:

- Personal identification information (Name and email address)
- Institution for working or reasearching
- Information about intolerances or allergies, if any
- ADEIMF conference proposals (papers)
- Payment methods and administrative information for payment receipt documents (fiscal code)
- Details about your conference participation

## How do we collect your data?

Through Confnow! systems you provide ADEIMF databases with most of the data we collect. We collect data and process data when you:

- Register online as a simple conference registered user
- Submit a paper or a keyword proposal for the annual conference
- Submit further personal data (fiscal code, personal address) for payment receipts
- Upload whatever document concerning a completed payment (Bank transfer)
- Voluntarily complete a customer survey or provide feedback via email

ADEIMF/Confnow! may also receive your data indirectly from the following sources:

- Submissions by *other* papers or keywords where you are registered as co-proponent, i.e. meaning your name and email are filled in.

### How will we use your data?

ADEIMF/Confnow! collect your data so that we can:

- View, list and manage your submitted papers or keywords
- Email you with any needed feedback concerning the submission process as well as the acceptance process, if requested by the current conference policies
- Email you with confirmation about your registration to the conference as participant
- Forward your email and amount to pay to an external payment system (Paypal) for the only purpose of completing the payment itself
- Compile an invoice document for payments concerning conference participation

If you agree and if requested by the conference policies, ADEIMF will share your data with external companies so that they may offer you their services

- PayPal
- Stripe
- Google Analytics
- Google ReCaptcha
- Zoom

When ADEIMF processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

### How do we store your data?

ADEIMF securely stores your data through Confnow! support at Aruba ([https://www.aruba.it/informativa\\_arubaspa.pdf](https://www.aruba.it/informativa_arubaspa.pdf)) hosting servers, and specifically in a single database.

Confnow! will keep your data for as long as ADEIMF conference organizing and scientific committee will ask to do so. At any rate this will be for no more than 15 years. Once this time period has expired, we will delete your data by erasing the database.

## Marketing

Confnow! would like to send you information about products and services that we think you might like.

If you have agreed to receive marketing, you may always opt out at a later date.

You have the right at any time to stop Confnow! from contacting you for marketing purposes.

## What are your data protection rights?

ADEIMF would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request ADEIMF for copies of your personal data.

The right to rectification – You have the right to request that ADEIMF correct any information you believe is inaccurate.

The right to erasure – You have the right to request that ADEIMF/Confnow! erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that ADEIMF restrict the processing of your personal data, under the condition that the hosted conference scientific committee agrees with it.

The right to object to processing – You have the right to object to ADEIMF’s processing of your personal data, under the condition that the hosted conference scientific committee agrees with it.

The right to data portability – You have the right to request that ADEIMF transfer the data that we have collected to another organization, or directly to you, under the condition that the hosted conference scientific committee agrees with it.
